

Benefit Restrictions

Section 436 of the Internal Revenue Code restricts the payment of certain kinds of benefits and the accrual of benefits under a single-employer pension plan that falls below specified funding levels. We have provided advice in connection with these restrictions, including advice on:

- Certification of funded level.
- Timing of valuations.
- Effect of restrictions on specific plan provisions.
