RE:	Chairman Rangel Requests Public Comment on Pension Technical Corrections			

At the meeting in New York last Tuesday, there was discussion of the PPA technical corrections and their impact on IRAs. The chairman of the Ways and Means Committee just requested comments on those technicals. Just to refresh, the main provisions affecting IRAs under H.R. 3641 (the Senate version is S. 1974) are:

1. Offering nonspouse beneficiary rollovers become mandatory in 2008.

[From the following provision: "(e) Amendments Related to Section 829-

(1) Section 402(c)(11) of the 1986 Code is amended--(A) by inserting `described in paragraph (8)(B)(iii)' after `eligible retirement plan' in subparagraph (A), and (B) by striking `trust' before `designated beneficiary' in subparagraph (B).

(2)(A) Section 401(a)(31)(D) of the 1986 Code is amended by adding at the end the following new sentence: `Such term shall include any distribution which is treated as an eligible rollover distribution by reason of section 402(c)(11), 403(a)(4)(B), 403(b)(8)(B), or 457(e)(16)(B).'

(B) The amendment made by subparagraph (A) shall apply with respect to plan years beginning after December 31, 2007."]

2. Clarification of the manner of calculating basis for charitable IRA distributions.

3. Clarification that inherited IRA to inherited IRA rollovers must be direct transfers.

4. Extension of automatic enrollment to SIMPLE IRAs and SARSEPS.

## Chairman Rangel Requests Public Comment on H.R. 3361, a bill to make technical corrections to the "Pension Protection Act of 2006"

Congressman Charles B. Rangel (D-NY), Chairman of the Committee on Ways and Means, today announced that the Committee is requesting comments from the public on H.R. 3361, a bill that would make certain technical corrections to the "Pension Protection Act of 2006." The bill was introduced on August 3, 2007.

#### **BACKGROUND:**

The Pension Protection Act of 2006 (PPA) (P.L.109-280) was signed into law on August 17, 2006. In general, the PPA made significant changes to many areas of pension law, including (1) funding rules for single-employer and multi-employer defined pension plans; (2) pension plan disclosure to plan participants; (3) investment advice, prohibited transactions, and fiduciary rules; (4) benefit accrual standards; (5) deduction limits for single-employer and multi-employer defined pension plans; (6) permanency of certain pension provisions, including increased contribution limits for defined contribution plans such as 401(k); (7) improved portability and distribution of pension benefits, including non-spousal rollovers; and (8) automatic enrollment for 401(k) plans.

The PPA Technical Corrections bill, introduced in both the House and the Senate on August 3, 2007, would enact technical modifications to certain provisions contained in the PPA. These technical corrections would permit the underlying provisions to be implemented as Congress intended. Some of the technical corrections, such as the corrections to "combined plan limits" and "nonspousal rollovers," have a pressing urgency. Therefore, it is important to perfect this legislation for possible passage before the end of this year. These technical changes are needed to provide necessary guidance on many of the provisions.
